Tailored and comprehensive: Support options for your child

Children with/at risk of disability should be supported individually, which is why a variety of integration support services are available up until school enrolment.

Special education services play a key role and include all measures that help children to thrive and develop their personalities.

These services can be provided, for example, at nurseries, in in-home day care or at early intervention centres. They can also be combined with medical therapy services at interdisciplinary early intervention centres.

As of 2020, Landschaftsverband Rheinland (LVR) alone will be responsible for the special education services provided at these institutions for the first time. The Federal Participation Act (BTHG) regulates this change to integration support.

The aim: Children with disabilities and their parents should be able to take part in all aspects of social life as they see fit – regardless of where they live and the form of support they require.

Special education services provided at institutions

What are special education services?

Special education services promote social inclusion and are designed to increase the independence of children with/at risk of disability and nurture their social abilities and development. A variety of measures support children in their learning development, in their social behaviour and in their emotional experiences. These include any necessary non-medical therapeutic, psychological, special education and psychosocial services as well as advice for their legal guardians.

Where are special education services provided?

- In combination with educational services and, if required, services dedicated to medical rehabilitation at nurseries.
- In combination with educational services provided through in-home day care.
- As one-to-one special education services provided in the form of early intervention (e.g. at early intervention centres). This includes diagnosis, development support with a focus on special educational needs, and advice for parents.
- In combination with medical therapy services as 'complex early intervention services'. Provided by a variety of occupational groups in collaboration, this particularly extensive form of support examines the child and their family as a whole and includes diagnosis, a support and treatment plan, and its interdisciplinary implementation. The costs for 'complex early intervention services' are divided among LVR and health insurance companies, depending on the focus of treatment.



Children who require more extensive support also receive some of their special education services at special needs nurseries. These institutions should gradually be incorporated into the general system of standard nurseries in the years to come, ensuring that demand for more extensive support can also be met at standard institutions.

Uninterrupted services and seamless transition

The BTHG is overhauling integration support, which represents a milestone on the path to enabling people with disabilities to take part in social life as they see fit. As LVR introduces this new system, it will make the transition as seamless as possible for all those involved. This applies in particular to children who are eligible for services as well as their parents.

A variety of transition rules are thus being put into place, including first and foremost LVR support in early childhood education, which so far has been voluntary: the Flnk initiative for children with disabilities at nurseries and the IBIK initiative for children in in-home day care. These are being adjusted in line with the new legal requirements of the BTHG.

The seamless transition should ensure that children with disabilities receive their services without interruption.

Who is eligible for services?

Children eligible for services

Children who have or are at risk of

- physical or
- mental disabilities or
- psychological or
- sensory impairments

and are thus highly restricted in their social involvement are eligible for integration support.

Identification of needs

During the planning phase, LVR as the provider of integration support determines the individual needs of the child with disabilities, using a standardised tool for identifying requirements for children and adolescents (BEI_NRW KiJu). This process also addresses the service recipients' desires, in particular.

Additional services and costs

For children too young for school, LVR covers the costs of any and all special education services provided at institutions, regardless of the child's type of disability.

In addition, many other services and forms of support may be available for children with disabilities, including nursing, medical procedures, therapeutic equipment and treatments. The costs of some of these are covered by other entities such as local providers of welfare services and health and long-term care insurance companies.

General information: Because integration support is secondary to welfare services, LVR also determines if another provider is ultimately responsible for the service in question.


Advice at a location near you
